Enforcement of the Clean Water Act and related environmental laws is the Organization's chief pursuit.

4b (Code:) (Expenses \$ 275562. including grants of \$) (Revenue \$) Marine Program - The Marine Program works to promote ecosystem health and resiliency of Los Angeles County's coastal waters through monitoring and research, hands-on restoration and education, with frequent outreach and advocacy work relating to the operations of the State Coastal Conservancy, State Lands Commission, Ocean Protection Council, California Coastal Commission, Santa Monica Bay Restoration Commission, Los Angeles Long Beach Harbor Safety Committee, United States Coast Guard, California Department of Fish and Game, National Oceanic and Atmospheric Administration, National Marine Fisheries Service, National Marine Sanctuaries, United States Mineral Management Service, and the California Oil Spill Prevention and Response Technical Advisory Committee.
